

## **NICAEA - 1700**

# The First Ecumenical Council Yesterday and Today

October 3, 2025 | Kaunas, Lietuva

In A.D. 325, at Nicaea (present-day İznik, Türkiye), bishops representing the whole of Christendom gathered to address dogmatic disputes concerning the nature of God and other matters of concern to Christians. The Fathers of the Council initiated what would become the Niceno-Constantinopolitan Creed, adopted canons for the governance of the Church, and resolved practical questions of Christian communal life. The Council of Nicaea was significant not only for the Church of the fourth century; the doctrinal and other issues it began to address have remained relevant to this day. They continue to surface in theological scholarship and in various contexts of Christian life and spirituality. On the 1700th anniversary of the Council of Nicaea, we invite the scholarly community to mark the occasion by reflecting on the content of the Creed affirmed at the Council, the significance of the Council's twenty canons, and the Council's near and distant reception.

This conference is interdisciplinary and ecumenical: participating scholars include not only theologians but also historians, philosophers, art historians, linguists, and researchers and practitioners from related fields, representing Catholic, Orthodox, and Protestant traditions.

The conference will consist of a morning plenary session (20–30-minute presentations) and an afternoon session (15–20-minute presentations). Sessions are organized under the following sub-themes: Reception of Nicaea; Nicaea and Theology; Nicaea and History; Nicaea and the Arts; Nicaea and Apologetics.

#### **Keynote Speakers**

**Very Rev. Dr. Cyril Hovorun** — Orthodox priest-monk; Professor of Ecclesiology, International Relations, and Ecumenism at the Stockholm School of Theology (Stockholm, Sweden); Director of the Huffington Ecumenical Institute at Loyola Marymount University (Los Angeles, USA); and Visiting Professor at the Pontifical Gregorian University (Rome, Italy). More than 500 of his scholarly and public writings

have been published in 30 languages. Selected books: "Eastern Christianity in Its Texts" (London: T&T Clark, 2022); "Political Orthodoxies: The Unorthodoxies of the Church Coerced" (Minneapolis: Fortress, 2018); "Meta-Ecclesiology, Chronicles on Church Awareness" (New York: Palgrave Macmillan, 2015); "From Antioch to Xi'an: an Evolution of 'Nestorianism'" (Hong Kong: Chinese Orthodox Press, 2014).

**Rev. Dr. Saulius Rumšas, OP** — Dominican friar; Doctor of Catholic Theology and Licentiate of Orthodox Theology. Senior Research Fellow at the Department for the Studies of Ancient and Medieval Culture, Lithuanian Culture Research Institute. Research interests include patristics, dogmatic theology (especially the Trinity and Christology), and Christian anthropology. Recent publications include: "Theological and Anthropological Aspects of Gregory of Nyssa's Homilies on the Beatitudes" (Logos, 2016); "Is Man Created 'according to the Image of God' and/or 'according to the Likeness'? Theological Challenges in Basil of Caesarea's Commentary on Gen 1:26–27" (Annals of the Lithuanian Catholic Academy of Science, 2022); "Basil of Caesarea versus or adversus Origen? On Creation 'according to Likeness' (Gen 1:26–27)" (Annals of the Lithuanian Catholic Academy of Science, 2023); "Theōsis: The Concept of Deification from Antiquity to the Early Modern Period" (LKTI, 2024).

Assoc. Prof. Dr. Benas Ulevičius — a permanent deacon, dean and professor at the Faculty of Catholic Theology at Vytautas Magnus University. He is known for his catechetical ministry and is the host of Catholic radio programmes and the author of theological articles and books. Two monographs are worth mentioning: "Divine East: Post-Vatican Liturgical Reform and the Question of the 'Turning of the Altars'" (Aidai, 2002) and "Divine Play: On the Liturgical Mind" (Aidai, 2009). His academic interests include dogmatic theology, liturgical theology, and anthropology.
